The Role & Place of an Online Lecture

- The lecture as a part, not the totality, of a course
- Alignment with:
 - Programme
 - Course
 - Learning objectives
 - Learning outcomes
 - Your students' situations

Synchronous or Asynchronous?

- My preference? Asynchronicity
 - Replicability vs adaptability, flexibility
- Technical considerations
 - Network bandwidth
 - Whether streamed or not
 - Machine capability
- But context matters, e.g. time constraints

Format

- Text/static images
- Voiced over – pptx and ppsx
- Video

- Technical considerations (again)
 - Network bandwidth
 - Whether streamed or not
 - Machine capability
 - Your skills base (and your time)

Alignment Matters

- The usual considerations apply
- What are your students studying (why?)?
- How does your course fit into their programme of study?
 - Learning objectives
 - Learning outcomes
- What does your lecture need to achieve (in respect of course and programme)?

Your Audience and You

- Diversity, equality and inclusion considerations abound
- Where/how are your students studying?
- Synchronicity
 - Allow video off
 - Provide multiple means for participation (NB: think about management matters)
- Don't assume technical competence
- Your personal characteristics

Student Engagement

- Non-replicability issues
- Loss of non-verbal cues

- Know your students
 - As cohort or individually
- Speak to them directly
- Move beyond knowledge acquisition
 - Make connections

- Be flexible – adapt as necessary
 - Requires regular polling of students

Opportunities

- Value-added
 - Guest lectures (alignment issues apply)
 - Shared classrooms
 - Shared materials
- Considerations
 - Intellectual property
 - Student (and academic) overload
 - Solidarity

Summary

- Be sure you know what your lecture is there for
- The usual rules of pedagogy apply, you're just experiencing (probably) new constraints
- Make decisions bearing in mind your programme, your course, your students' and your own situation
- There are advantages as well as disadvantages in this circumstance.
