It feels like a very long time since the last in-person PSA conference: in Nottingham in April 2019. It was wonderful to be able to meet virtually last year. Now, thanks to a huge amount of hard work from many people, we are holding our first ever hybrid conference.

I know that many people are very excited about us being able to meet face-to-face: seeing friends old, hopefully making some new ones, and being able to get that face-to-face interaction that we have missed for two years. That it is all happening in the beautiful city of York is all the better. But the need to move online during the pandemic made lots of events more accessible to many people, and the PSA team is determined to try to provide the best possible experience for our online participants this year. Welcome from the Department of Politics at the University of York. We are delighted to host colleagues for three days of exciting conversations and debates at the 72nd PSA Annual International Conference.

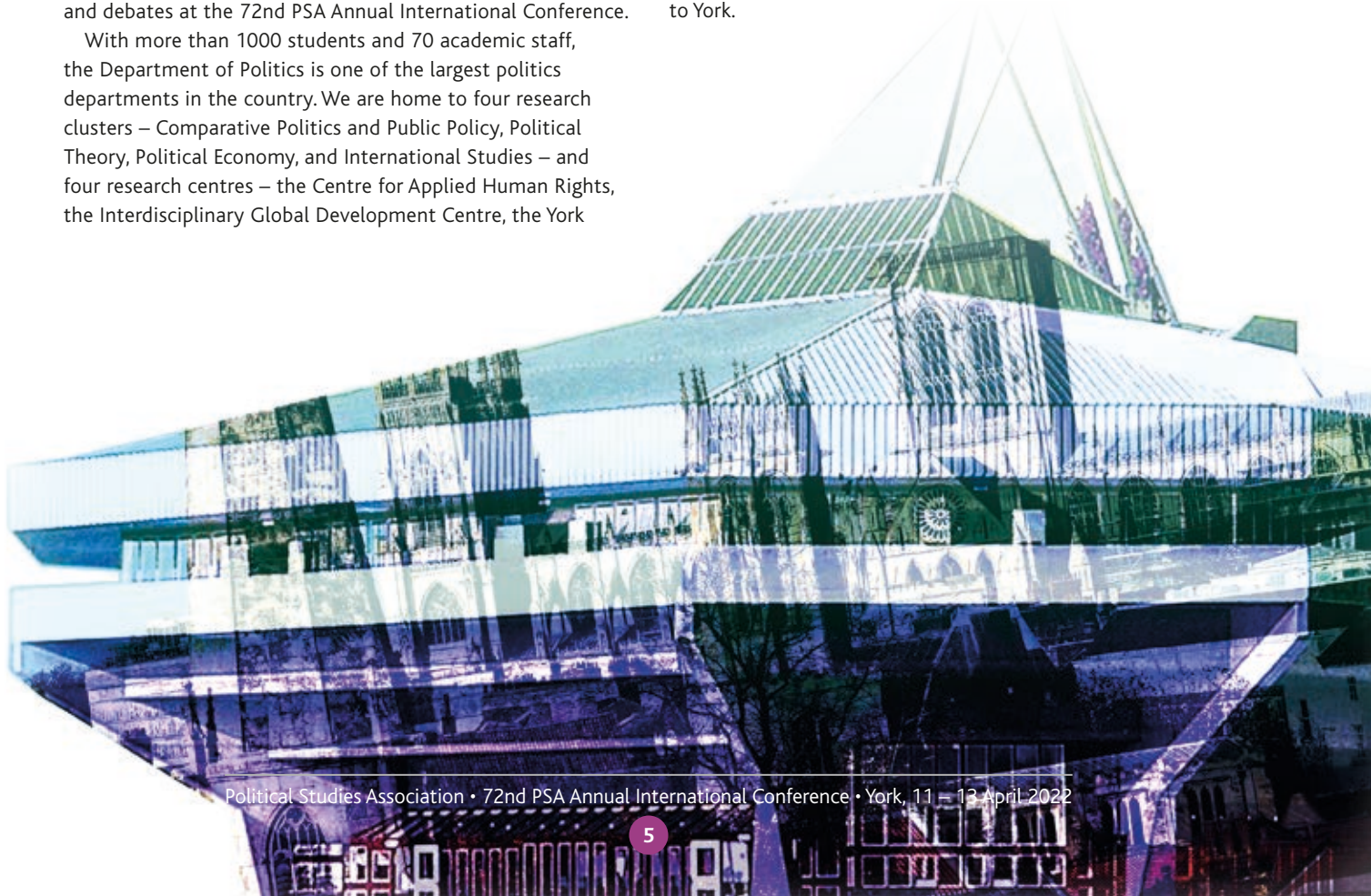

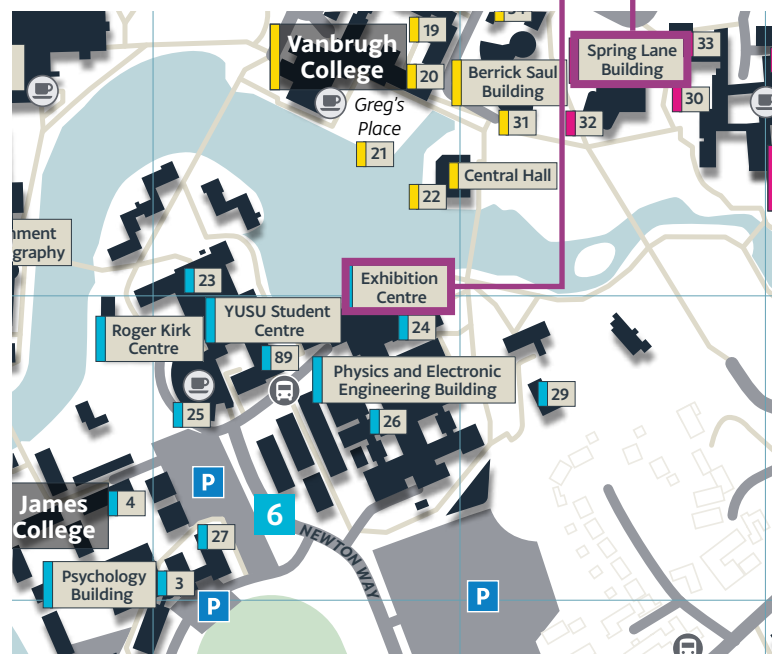
Getting the most out of Conference

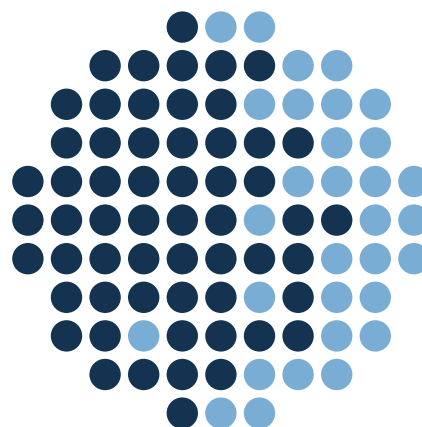

Sanam Naraghi Anderlini

Sanam Naraghi Anderlini has for over two decades been a peace strategist working globally on conflicts, crises, and violent extremism with a mix of civil society, governments, and the UN. She is the founder and Executive Director of ICAN and spearheads the Women's Alliance for Security Leadership which is comprised of independent women-led organisations active in 40 countries globally dedicated to preventing violence and promoting peace, rights and pluralism.

In December 2019, Sanam received an MBE in recognition for her work and for services to international peacebuilding and women's rights. She speaks four languages and holds an MPhil in Social Anthropology from Cambridge University. Iranian by birth, Sanam is a UK citizen, and has twin daughters.

Tshepo Madlingozi is an Associate Professor and Director of the Centre for Applied Legal Studies at Wits University. He has master's degrees in both Law and Sociology, and he received his PhD degree from Birkbeck, University of London. He is a Research Associate at the Chair for Critical Studies in Higher Education at Nelson Mandela University. He is the co-editor of South African Journal on Human Rights. He is a co-editor of Symbol or Substance: Socio-economic Rights in South Africa (Cambridge UP) and a co-editor of Introduction to Law and Legal Skills in South Africa, 2nd Edition (Oxford UP South Africa).

He sits on the boards of the following civil society organizations: the Rural Democracy Trust; and the Mining-Affected Communities United in Action/Women-Affected by Mining Action. He is also a member of the Steering Committee of the African Coalition for Corporate Accountability (ACCA), and a member of the advisory board of Health Justice Initiative. For thirteen years (2015-2018) he worked with and for Khulumani Support Group, a 120 000-strong social movement of victims and survivors of Apartheid as National Advocacy Coordinator & later the Chairperson.

Magid Magid is a Somali-British race and climate justice activist and author who came to the UK as a refugee aged five. He is Founder and Director of Union of Justice, a European, independent, people of colour led organisation dedicated to racial justice and climate justice.

He was a member of the European Parliament representing Yorkshire & the Humber, Mayor of his beloved city, Sheffield and was also an elected councillor representing his community. Magid was named one of TIME's 100 rising stars shaping the future of the world.

About the York Convenors

Dr Indrajit Roy and Dr Sara de Jong are delighted to welcome you to the PSA22 hybrid conference 'Politics from the Margins'. We are so happy that some of you can join us in person at the University of York campus, and that those who cannot travel in the face of health, financial or visa restrictions, can still participate in this intellectual and social exchange.

With this year's conference theme, we want to bring to the forefront some of the political actors, events and regions, which are usually relegated to the margins. By considering how our analysis of politics changes if we take the margins as our vantage point, we hope to create space for new perspectives and challenge our discipline. Inspired by the growing calls for decolonising research and teaching in politics, this PSA conference seeks to cast a critical and reflexive eye on political science scholarship by considering what or who is positioned on the margins within our scholarship and academic community and what could be gained by including marginalised perspectives, voices and topics.

Dr Sara de Jong



Dr Sara de Jong is a Senior Lecturer at the Department of Politics at the University of York and co-director of the Interdisciplinary Global Development Centre. Her broader research interests include the politics of

NGOs and civil society, especially in the field of migration and gender; (post)colonial politics and brokers as political actors.

Since 2017, Sara has worked on a research project investigating the claims to protection and rights by Afghan interpreters and other Locally Employed Civilians, who worked for Western troops. The research also uncovers the strategies and activities of their advocates, including veterans, lawyers and civil society actors.

Alongside her research, Sara is committed to engaging with formal and grassroots politics, from providing oral evidence to Parliamentary Select Committees to volunteering as a befriender in an immigration detention centre.

She is the author of *Complicit Sisters: Gender and Women's Issues across North-South Divides* (OUP, 2017) and co-editor with O. Rutazibwa and R. Icaza of the edited volume *Decolonization and Feminisms in Global Teaching and Learning* (Routledge, 2018). Her work has been published in international journals, including *Security Dialogue*, *PS: Political Science and Politics*, the *Journal of Ethnic and Migration Studies* and the *International Feminist Journal of Politics*.

Dr Indrajit Roy



Dr Indrajit Roy is Senior Lecturer at the University of York's Department of Politics and co-director of the Interdisciplinary Global Development Centre. His research and teaching strengthen critical approaches to global development politics through three

projects: (i) The comparative 'politics of hope' in cities of the global South and global North; (ii) The attempts by states and societies in the global South to promote inclusive growth; and (iii) The impact of the BRICS as "rising powers" on the global order.

Indrajit is committed to collaborative research that not only involves scholars from beyond the social sciences but includes activists, artists, think-tanks and policy-makers. His teaching is oriented towards perspectives that contribute to decolonising and diversifying the curriculum.

He is the author of *Politics of the poor: Negotiating democracy in contemporary India* (CUP, 2018). He is currently co-writing a textbook on *Global Development Politics*, under contract with Routledge. His work has been published in peer-reviewed journals such as *World Development*, *Journal of Peasant Studies* and *PS: Political Science and Politics*. He contributes frequently to the media such as BBC, Guardian, Independent, The Conversation and Indian Express.

Dr Nicole Lindstrom

Dr Nicole Lindstrom researches and teaches comparative European political economy, focusing on post-socialist states on the margins of Europe. Her current research focuses on the political economy of populism, European industrial policy, and Brexit.

Dr Alfred Moore

Alfred Moore works on contemporary political theory. He has written on topics including the politics of expertise, the role of anonymity in the networked public sphere, and is currently researching the role of ideas of competition in democratic theory and practice.

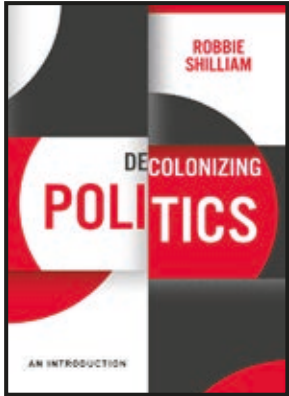
Dr Dan Keith

To disguise behind the bars that represent the statistics of a growing aggression in recent times the work of someone who is devoted to the defense that touches the limits of impotence, seems like a nod to reality.

Priest Alejandro Solalinde, a well known activist, is probably the most active human rights defender in Mexico. He has publicly decried the abuses committed against undocumented Latin American migrants and has been threatened by criminal organizations that traffic humans, arms, and organs. To be a human right defender is now for some almost a romantic idea. In Mexico, one of the more difficult regions of the planet to practice this labor, has become a matter of life and death.

Divine is a kind of tacit plea that is understood only from its own overlap; is also a reflection of the offense we inflict as a society to whom, fighting everyday, doesn't understand how we got here.

Invisible Vox Pops (2020-2022), Les Monaghan

Vox pops is the term used in the media for a portrait and quote package usually made on the street. Stemming from *Vox populi*, meaning, the voice of the people, it is often used as the supposed voice of the majority of the people. This is further translated as the will of the people and used to justify government actions.

Les Monaghan's photos feature an unseen majority rarely represented or asked for their opinion on current events. Their lives are unreported and unrepresented in policies. Yet their feelings, their needs, their fears probably chime with many.

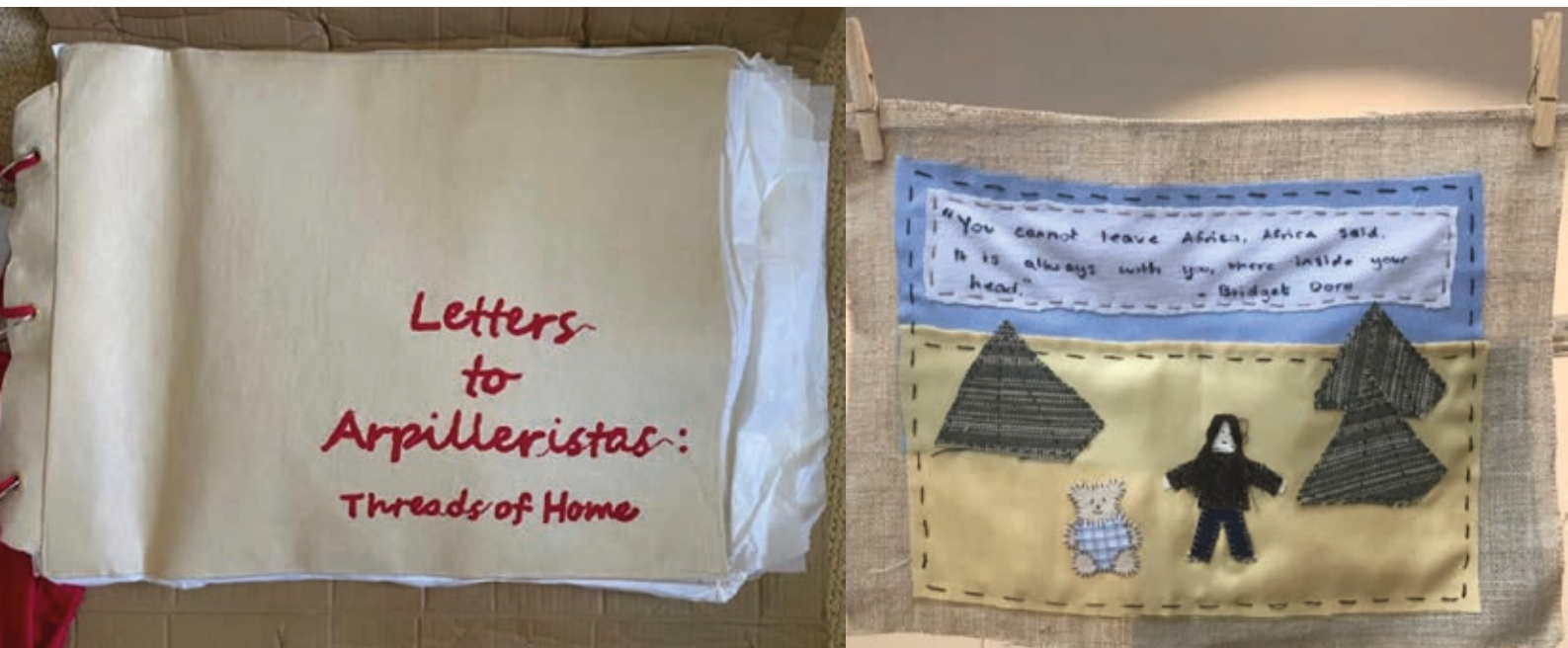
These voices form the Invisible Vox Pops series created in Doncaster, South Yorkshire. In the context of collaboration with University of York academics Dr Tom O'Brien and Dr Sara de Jong for the project 'Identifying Community Responses to Compounding Crises: The Case of Doncaster, South Yorkshire', supported by the Morrell Trust, Les Monaghan created a follow-up series in 2021/2022.



Letters to Arpilleristas: Threads of Home

'Letters to Arpilleristas: Threads of Home' is a textile book crafted in response to Threads, War and Conflict, an exhibition project commissioned and led by Lydia Cole (University of York), alongside a team of organisers at University of St Andrews. Stitching with the margins of international politics, workshop participants were inspired by Chilean arpilleristas who spoke out against political violence during the Pinochet dictatorship. During the Threads workshops, participants crafted a response to the powerful testimony of arpilleristas. Student makers were inspired by an object, artefact, or material which represented 'home'; particularly, what they might miss if faced with a situation like the arpilleristas.

The workshops were led by Lydia Cole and Laura Mills (University of St Andrews), with Sheila Mortlock. The pieces within the book were crafted by students and lecturers from Scottish Higher Education Institutions. The pieces were stitched together into their book form by Deborah Stockdale.



Precarious transitions: Mobility, development and citizenship in a Rising Power, Indrajit Roy with Atul Anand, Zaheeb Ajmal and Ankur Jaiswal

The Precarious transitions research project, funded by the ESRC, ethnographically examines the disjunctions between mobility, development and citizenship experienced by India's 100 million migrants. On the one hand, social movements and political change challenged caste hierarchies in the countryside, generating hope for a transition to a better future. On the other hand, limited livelihood opportunities and growing inequalities dashed those hopes and rendered those transitions precarious.

This exhibition offers a glimpse into the many worlds inhabited by India's internal migrants as they journey through the rural, the urban and in-between, building the country from below. Gratitude to the dedication of the ethnographers Ankur Jaiswal, Atul Anand and Zaheeb Ajmal who enriched the project with their sensitive portrayal of the hopes and despairs harboured by their interlocutors.

The exhibition tells the backstory of the massive exodus witnessed across India during the summer of 2020, triggered by the ill-planned lockdown imposed by its government.

Uprising, Steve Kyenze

Steve Kyenze and the young artists of Nyota Art Gallery, Kenya produced a street mural for the Navigation Risk project.

'The mural focuses on the uprising towards insecurity and how ordinary people rise peacefully in response to brutality against humanity.' Steve Kyenze

The mural and the poem 'Uprising' were inspired by 'Safe Insecure' a verbatim poem composed by Juliana Mensah from the interview transcript of a Kenyan woman human rights defender working to stop extra-judicial killings and gender-based violence.

We are Here Because You Were There: Afghan Interpreters in the UK, Andy Barnham and Sara de Jong

This collaborative project documents the experiences of Afghan interpreters for the British Army, recently resettled to the U.K. under the Afghan Relocation and Assistance Policy. Together their individual stories and images reflect the structural and lasting impact of Britain's military intervention and migration policies.

Photographer Andy Barnham has edited the portraits to help anonymise the interpreters still at risk and with family in Afghanistan under threat. The portraits presented are a composite of up to a dozen frames which have been blurred and then merged to present a final portrait. This process can also be seen as inflicting trauma on the portraits, in acknowledgement of events experienced when serving with NATO forces and escaping Afghanistan.

The quotes are selected from interviews conducted by Dr Sara de Jong (University of York), covering the Afghan interpreters' experience of working for the British Armed Forces, their evacuation, and early experiences in the U.K.

Digital Art and Films

Dust on Paper, Emilie Flower, UK 2017

There is a lot of pressure on activists to show that they are brave, making it very difficult to talk about their feelings and emotions. Human rights interventions often limit discussions of emotion, but emotions - fear, passion, sadness, joy - are what make change possible and living worthwhile.

'Dust on Paper' is one of 16 verbatim poems composed by Juliana Mensah and arranged from interview transcripts from research project 'Navigating Risk, Managing Security, and Receiving Support. The largest study of its kind, this research project focused on how human rights defenders navigate risks, manage their personal security, and receive protection support in five countries - Colombia, Mexico, Egypt, Kenya and Indonesia. Through interviews, focus groups and surveys with over 400 defenders at risk, this project proposed new ways in which protection can be reconceptualised and reorganised for greater effectiveness. The project was led by Dr Alice Nah at the Centre for Applied Human Rights.

Based on the poem and on readings of LGBT interview transcripts from Mexico and Colombia, *Dust on Paper* (04:00 mins) is a magi real film that describes the immersive experience of defending human rights. The soundtrack is read by the Colombian human rights defender Johana Rocha Gómez.

'Mahmoud Dicko, l'imam qui appartient à la terre' & Madame Cissé, prédicatrice de l'équité" (tr. 'Mahmoud Dicko, the imam who belongs to the earth' & 'Madame Cissé, preacher of fairness')

The two videos are part of an ongoing series of digital stories produced in the context of the Generating Respect Project, hosted at the Centre for Applied Human Rights and York Law School (University of York). The Project, funded by the UK's Economic and Social Research Council and led by Ioana Cismas (University of York) and Ezequiel Heffes (Geneva Call), investigates how religious leaders influence the behaviours of State and non-State parties to armed conflicts.

The Project, which embraces an interdisciplinary, practice-oriented, and art-reliant methodology, seeks to centre the voices of religious leaders from six research contexts: Mali, Colombia, Myanmar, Libya, Syria and Yemen.

The two digital stories, produced by Nicolás Braguisky Cascini, portray two influential Malian religious leaders and are based on interviews conducted by Mohamed Assaleh (formerly Geneva Call Mali) and Piergiuseppe Parisi (University of York) in Bamako (Mali) between July and August 2021.

Inundación (Flood) & Minería (Mining), Lanceros Digitales of the Confederación de Nacionalidades Indígenas de la Amazonía Ecuatoriana

The Human Rights Defender Hub at the Centre for Applied Human Rights has supported collaborations of artists and activists across the world who have responded to the implications of Covid-19 for human rights defenders, activism, and civic space. Using theatre, music, zines, poetry and drag performance, the collaborations have addressed socio-economic inequalities, the challenges faced by women and Indigenous peoples, and the threats posed by populism.

The Ecuadorian Amazon is a diverse place where various indigenous identities coexist, as well as settlers with their modernizing logics and practices, in the midst of growing extractivist pressures. For many people and ecosystems in the Amazon rainforest, this reality is only worsening, as these territories and communities were already in a state of emergency before the pandemic.

In *Las Otras Pandemias* (The Other Pandemics) the voices of Amazonian activists are portrayed from a sensory, visual language—with hopes that their reflections will generate empathy and interest in the struggle they face in their different territories and nationalities.

Inundación (Flood): On 17 March 2020 the river Bobonaza broke its banks and flooded the Sarayaku community. The flooding destroyed three bridges, dozens of families lost their homes and crops, and the infrastructure that brought water to the community was damaged.

The only way to face this loss and also COVID 19 was through community organisation.

Minería (Mining): Despite the complexities of the pandemic, the Ecuadorian government insists on making way for ambitious mega mining projects that cause destruction and irreparable damage in the wilderness. Extractivism doesn't stop in the face of the humanitarian and health crisis so the Shuar Arutam people are determined to continue their struggle.

Reimagining citizenship: The politics of the Citizenship Amendment Act in India

Natasha Badhwar and Abdul Kalam Azad with Indrajit Roy

The two videos are part of six ethnographic videos produced by the Reimagining Citizenship research consortium, a global collaboration of academics, activists and writers. The consortium is supported by funding from the Arts and Humanities Research Council and is led by Dr. Indrajit Roy. Co-investigators on this consortium include Harsh Mander at Centre for Equity Studies, Natasha Badhwar at Aman Biradari, Mujibur Rehman at Jamila Milial Islamia, K Ravi Raman of the Kerala State Planning Board, Mohsin Alam of Jindal School of Government, Buddhadeb Halder at the University of York, and Abdul Kalam Azad, an Assam-based poet and a doctoral student at Vrije University in Amsterdam. The team uses digital ethnographies, emotional testimonies, and transformative story-telling to chronicle ongoing contestations over citizenship in India today.

The two videos are presented through Miya poetry, a protest poetry developed by Bangla-speaking Muslims of India's Assam State to contest the discriminatory attitudes of state and society towards them.

Detention Camp conveys the trauma faced by Bengali Muslims in Assam. Their Indian citizenship is "doubtful" (a legal category) and who face the prospects of being sent to detention camps, thereby rendering uncertain their very existence.

Aar koto din (How many more days) illustrates the longing for freedom from oppression which animates everyday life of people anxious about the growing shadows over their citizenship status. It does this through an imaginary conversation between the poet and the revolutionary Che Guevara.

Salobre

Coastal lagoons are the margins between salt water and freshwater. Along the Caribbean Colombian coast, the shifting fish and shellfish stocks associated with the lagoons and their fringing mangrove forests provide a livelihood for the communities that live and work there. These people have been there for generations, but are at the margins of society, and many Colombians consider them to represent the last frontier of civilization. These marginal coastal areas are affected by floods and droughts, pollution, global warming and sea level rise.

In *Salobre*, a film voiced entirely by communities, fishers and farmers reflect on their life on and around the vast Ciénaga Grande de Santa Marta. They describe how the lagoon and the mangroves provide them with resources, how they experience and adapt to challenges such as periods of drought and flood, and their dreams and fears for the future.

The production of *Salobre* was supported by the Natural Environment Research Council (NERC) and the Department for International Development (DFID) Understanding the Impacts of the Current El Niño Event programme (Grant no. NE/P003974/1, Principal Investigator Professor Piran White, University of York). We designed the project in coordination with scientists and technical teams already working in the area and known to the communities.

6. Audio-Visual Equipment and Support

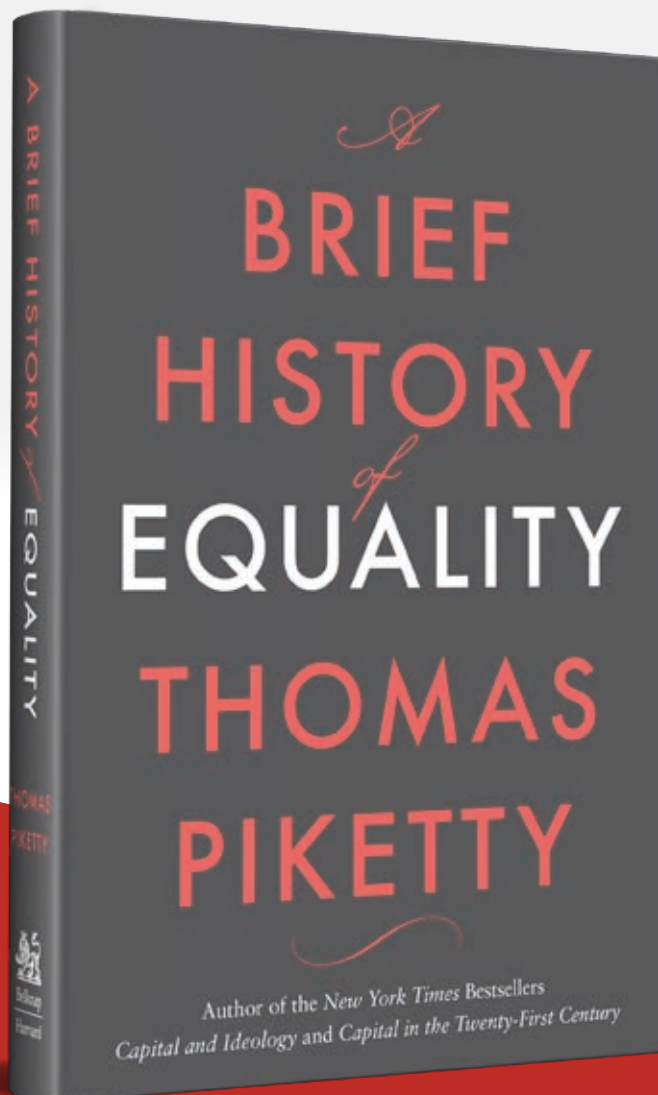
